Name Ideas Solicited for Two New Schools

Pensacola, FL: Everyone has a chance to submit ideas for names for the new middle school and the new elementary school until March 31, 2016! ECSD has received over 20 suggestions for each school already. Please help remind everyone to send in their ideas!!!

The new middle school property is located at 6001 W. Nine Mile Rd. and the new elementary school will be located at 900 W. Kingsfield Rd. Both schools will be completed in the spring of 2018.

Members of the community may submit a school name for consideration by the Facility Naming Selection Committee and ultimately by the School Board of Escambia County. Only complete submissions will be considered by the committee and submissions must be submitted by March 31.

The information needed for a submission includes:

1. Your name and contact information (phone number and email address)
2. Your proposed name for the elementary school or the middle school.

If your suggestion involves naming either school for a person, please also provide this additional information:

3. Full name of the individual.
4. Is/was the person a resident of Escambia County? (yes or no)
5. Does/did the individual contribute to programs served by the Escambia County School District? (yes or no)
6. Is/was the individual an employee of the Escambia County School District? (yes or no)
7. Is/was the individual a graduate of an Escambia County school? (yes or no)
8. Number of years of direct service to the school district? ____
9. Number of years of continued (indirect) service to the School District (supporting documentation may be required) ____
10. Number of years of continued public service to the community (supporting documentation may be required) ____
11. Is/was the individual a veteran of military service? (yes or no)
